AFT Pharmaceuticals (AFT) is a climate-reporting entity under the New Zealand Financial Markets Conduct Act 2013.

Currently AFT emission data is calculated using methodologies in line with New Zealand's Climate Related Disclosure (CRD) regime and New Zealand's Climate Standards. Our climate Green House Gas inventory has been prepared in accordance with ISO 14064-1:2018. Our climate reporting is reviewed by Toitu Envirocare. Toitu is a wholly owned subsidiary of the New Zealand Government-owned Crown Research Institute. Toitu Envirocare currently serves over 800 clients both in New Zealand and worldwide.

This reporting is submitted at the global enterprise level (AFT Pharmaceuticals Ltd) and therefore data in this CRP submission will utilise this data.

In future years as our reporting capabilities mature, we may be able to provide more granular UK specific data, and if this occurs, we may be able to provide clarification on any deviations from the baseline in this document. At this point in time, it is relevant to state that AFT UK Pharma Ltd is a very new organisation founded in 2023 and employs only 4 FTEs currently.

AFT has not previously assessed or reported emissions so our baseline is 2024.

Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets:


- Our short-term target is a 42% absolute reduction to 776.16 tCO2e by 2029-2030. This is a reduction of 42% of our scope 1-3 Emissions on our 2024 base year.
- Our long-term target is to make AFT Pharmaceuticals Ltd net zero in its operations by 2050. This will be achieved via a 90% absolute reduction in our scope 1-3 carbon emissions with the final 10% being neutralized via permanent removals. In line with the below graph.



Near-term SBTs: 5-10 year emission reduction targets in line with 1.5°C pathways.

Long-term SBTs: Target to reduce emissions to a residual level in line with 1.5°C scenarios by no later than 2050.

Neutralization of residual emissions: GHGs released into the atmosphere when the company has achieved their long-term SBT must be counterbalanced through the permanent removal and storage of carbon from the atmosphere.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

AFT Pharmaceuticals has just completed their base year in 2023-2024. We have not completed any carbon reduction projects yet. We will be running several projects across the group to achieve our ambition of becoming net zero by 2050.

Future Projects Include:

- Reducing Business Travel increasing TEAMS and Zoom Meetings.
- Reducing office electricity usage.
- Procuring 100% renewable energy for all remaining electricity needs.
- Transitioning company fleet from ICE to Hybrid Vehicles then to Electric vehicles as Electric Vehicle infrastructure improves.
- Increasing employee engagement and education in the benefits of Net Carbon Reduction.
- Increasing Supply Chain engagement and education in the benefits of Net Carbon reduction.
- Working with suppliers on sustainability performance.
- Inclusion of Net Carbon Reduction targets into Corporate Strategy and Corporate Governance.

- Optimising freight deliveries to be less carbon intensive.
- Utilising less carbon intensive freight options.
- Transitioning to sustainable fuels for our freight deliveries.
- Reporting against Metrics set and compliance with regulatory requirements.
- Enablers AFT has employed or plans to employ to deliver on these programmes include:
 - Corporate Strategy.
 - Refinements in Corporate Governance.
 - Risk assessment and management of potential climate driven business risks.
 - Setting of Metrics.
 - Targets and reporting.
